1. Serving size is to be 16 oz. pours of beer and 6 oz. pours of wine.
2. Beverage to be served to individuals wearing the official event wristband with a valid ID that verifies that the participant is of legal drinking age in the state of North Carolina.
3. All beverages must be consumed in the designated area of the festival.
4. Vendors have the responsibility to serve responsibly and shall politely refuse service to anyone they feel is too intoxicated. Anyone determined to be serving intoxicated individuals will be removed from the festival premises.
5. No full bottles are allowed to be sold or given away.
